# PROPOSED GENERAL MANDATES TO BUY BACK SHARES AND TO ISSUE SHARES, RE-ELECTION OF DIRECTORS AND NOTICE OF 2015 ANNUAL GENERAL MEETING

# INTRODUCTION

The purpose of this circular is to provide you with information in connection with the convening of the 2015 Annual General Meeting and explanation in connection with the matters to be dealt with at the 2015 Annual General Meeting.

The Notice is set out on pages 13 to 16 of this circular.

Shareholders are advised to read the Notice and to complete and return the accompanying form of proxy for use at the 2015 Annual General Meeting in accordance with the instructions printed thereon.

For the purpose of determining Shareholders' eligibility to attend and vote at the 2015 Annual General Meeting, the register of members of the Company will be closed from Wednesday, 27 May 2015, to Thursday, 28 May 2015, both days inclusive, during which period no transfer of shares will be effected. As such, all transfers accompanied by the relevant share certificates must be lodged with the Company's share registrar, Tricor Secretaries Limited of 22nd Floor, Hopewell Centre, 183 Queen's Road East, Hong Kong by 4:30 p.m. on Tuesday, 26 May 2015.

Pursuant to the Listing Rules, all resolutions put to vote at the 2015 Annual General Meeting shall be taken by poll except where the chairman of the meeting, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands.

#### **BUSINESS OF 2015 ANNUAL GENERAL MEETING**

# Resolution (1) - Receiving the audited consolidated financial statements

The audited consolidated financial statements of the Company for the year ended 31 December 2014 together with the reports of the directors and the auditor were set out in the Annual Report, and were sent together with this circular to the Shareholders on the same date.

The audited consolidated financial statements have been audited by Deloitte Touche Tohmatsu and reviewed by the audit committee of the Company.

# Resolution (2) - Declaration of final dividend

The Board of Directors has recommended a final dividend of HK45 cents per share (2013: HK45 cents per share). Together with the interim dividend of HK45 cents per share (2013: HK42 cents per share) paid during the year, total dividends for the year ended 31 December 2014 amounted to HK90 cents per share (2013: HK87 cents per share).

Subject to approval by the Shareholders at the 2015 Annual General Meeting, the final dividend will be paid on or about Monday, 15 June 2015 to Shareholders whose names appear on the register of members of the Company on Friday, 5 June 2015.

For the purpose of determining Shareholders' entitlement to the final dividend, the register of members of the Company will be closed on Friday, 5 June 2015, on which no transfer of shares will be effected. As such, all transfers accompanied by the relevant share certificates must be lodged with the Company's share registrar, Tricor Secretaries Limited of 22nd Floor, Hopewell Centre, 183 Queen's Road East, Hong Kong by 4:30 p.m. on Thursday, 4 June 2015.

#### Resolution (3) - Re-election of Directors and determination of Directors' remuneration

In accordance with Article 101 of the Articles of Association of the Company, Mr. Xu Bo, Dr. Lo Ka Shui and Prof. Woo Chia-Wei shall retire at the 2015 Annual General Meeting and, being eligible, have offered themselves for re-election.

Pursuant to the code provisions set out in the Corporate Governance Code of Appendix 14 to the Listing Rules, if an independent non-executive director serves more than 9 years, his further appointment should be subject to a separate resolution to be approved by shareholders. Dr. Lo Ka Shui and Prof. Woo Chia-Wei have acted as Independent Non-Executive Directors of the Company since March 1996, serving the Board for more than 9 years. Separate resolutions will be proposed for their re-election at the 2015 Annual General Meeting.

The Board considers that Dr. Lo Ka Shui and Prof. Woo Chia-Wei remain independent as they have satisfied all the criteria for independence set out in Rule 3.13 of the Listing Rules.

Shareholders are recommended to vote in favour of the re-election of Mr. Xu Bo, Dr. Lo Ka Shui and Prof. Woo Chia-Wei as the Board believes that their qualifications and extensive experience are of great value to the Board. Their biographical details and other information which are required to be disclosed by the Listing Rules are set out in Appendix II to this circular.

The remuneration committee of the Company has made recommendation to the Board on the directors' remuneration for the year ending 31 December 2015, and the basis of determining the directors' remuneration is set out in the corporate governance report of the Annual Report.

# Resolution (4) - Re-appointment of auditor and determination of auditor's remuneration

The audit committee has recommended to the Board for the re-appointment of Messrs. Deloitte Touche Tohmatsu as auditor of the Company until the conclusion of the next annual general meeting.

Shareholders' approval to delegate the authority to the Directors to determine the auditor's remuneration for the year ending 31 December 2015 is required at the 2015 Annual General Meeting.

#### Resolution (5) – General mandates to buy back shares

At the annual general meeting held on 28 May 2014, a general mandate was given to the Directors to buy-back Shares up to a maximum of 10 percent of the issued share capital of the Company at the date of passing of the ordinary resolution. Such mandate will lapse at the conclusion of the 2015 Annual General Meeting. An ordinary resolution set out in the Notice will be proposed at the 2015 Annual General Meeting to grant the Buy-back Mandate to the Directors.

As at the Latest Practicable Date, the total number of Shares in issue was 1,083,776,600. On the basis that no further Shares are issued or bought back prior to the date of the 2015 Annual General Meeting, the Company would be allowed under the Buy-back Mandate to buy back a maximum of 108,377,660 Shares, representing 10 percent of the total number of Shares in issue as at the Latest Practicable Date.

The Buy-back Mandate would continue in force until the conclusion of the next annual general meeting of the Company or the expiration of the period within which the next annual general meeting of the Company is required by law or the Articles of Association of the Company to be held or until the Buy-back Mandate is revoked or varied by an ordinary resolution of the Shareholders in general meeting, whichever is the earlier.

The explanatory statement required by the Listing Rules to be included in this circular is set out in Appendix I to this circular.

#### Resolutions (6) and (7) – General mandate to issue shares

At the annual general meeting held on 28 May 2014, a general mandate was given to the Directors to allot, issue and deal with Shares (and securities exercisable or convertible into Shares) not exceeding 20 percent of the issued share capital of the Company at the date of passing of the ordinary resolution. The unused portion of the mandate will expire at the conclusion of the 2015 Annual General Meeting. Two ordinary resolutions will be proposed at the meeting to grant the Issue Mandate to the Directors and to extend the Issue Mandate by adding to it the number of Shares bought back by the Company under the Buy-back Mandate respectively.

As at the Latest Practicable Date, the total number of Shares in issue was 1,083,776,600. On the basis that no further Shares are issued or bought back prior to the date of the 2015 Annual General Meeting, the Company would be allowed under the Issue Mandate to issue a maximum of 216,755,200 Shares, representing 20 percent of the total number of Shares in issue as at the Latest Practicable Date.

The Issue Mandate would continue in force until the conclusion of the next annual general meeting of the Company or the expiration of the period within which the next annual general meeting of the Company is required by law or the Articles of Association of the Company to be held or until the Issue Mandate is revoked or varied by an ordinary resolution of the Shareholders in general meeting, whichever is the earlier.

### RECOMMENDATION

The Directors consider that the above recommendations are in the interests of the Company and the Shareholders. Accordingly, the Directors recommend the Shareholders to vote in favour of the above resolutions to be proposed at the 2015 Annual General Meeting.

This explanatory statement contains all the information required under the Listing Rules for you to consider the Buy-back Mandate.

The Listing Rules permit companies whose primary listings are on the Stock Exchange to buy back their fully paid up shares on the Stock Exchange subject to certain restrictions, the most important of which are summarized below:

#### **SHARE CAPITAL**

As at the Latest Practicable Date, the total number of Shares in issue was 1,083,776,600. On the basis that no further Shares are issued or bought back prior to the date of the 2015 Annual General Meeting, the Company would be allowed under the Buy-back Mandate to buy back a maximum of 108,377,660 Shares, representing 10 percent of the total number of Shares in issue at the Latest Practicable Date.

#### REASONS FOR SHARE BUY-BACKS

The Directors have no present intention to buy back any Shares and, whilst it is not possible to anticipate in advance those circumstances in which the Directors might think it appropriate to buy back Shares. Shares would only be bought back in circumstances where the Directors consider that the buy-back would be in the interests of the Company and the Shareholders. Such buy-back may, depending on market conditions and funding arrangements at the time, lead to an enhancement of earnings per Share.

#### SOURCE OF FUNDS

It is proposed that buy-backs of Shares under the Buy-back Mandate would be financed from internal funds and available banking facilities of the Company. In Share buy-backs, the Company may only apply funds legally available for such purpose in accordance with all applicable laws of Hong Kong and the Articles of Association of the Company.

#### WORKING CAPITAL OR GEARING POSITION

If the Buy-back Mandate was exercised in full at any time during the proposed buy-back period, it would not have a material adverse impact on the working capital of the Company or its gearing position (as compared with the position disclosed in the Company's published audited accounts for the year ended 31 December 2014). The Directors do not propose to exercise the Buy-back Mandate to such extent as would, in the circumstances, have a material adverse impact on the working capital of the Company or its gearing position (as compared with the position disclosed in the Company's published audited accounts for the year ended 31 December 2014) which in the opinion of the Directors are from time to time appropriate for the Company.

### DIRECTORS AND THEIR ASSOCIATES

None of the Directors nor, to the best of their knowledge and belief having made all reasonable enquiries, any of their associates (as defined under the Listing Rules), has any present intention, in the event that the Buy-back Mandate is approved by Shareholders, to sell Shares to the Company.

#### CONNECTED PERSONS

No Connected Persons have notified the Company that they have a present intention to sell any Shares (in issue or to be issued) to the Company or have undertaken not to do so, in the event that the Company is authorized to make Share buy-backs.

# UNDERTAKING OF THE DIRECTORS

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to buy back Shares pursuant to the proposed resolution in accordance with the Listing Rules, all applicable laws of Hong Kong and the regulations set out in the Articles of Association of the Company.

#### EFFECT OF TAKEOVERS CODE

If, as a result of a buy-back of Shares, a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. Accordingly, a shareholder or group of shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code and the provisions may otherwise apply as a result of any such increase.

As at the Latest Practicable Date, SIIC through its subsidiaries, namely Shanghai Investment Holdings Limited, SIIC Capital (B.V.I.) Limited, Shanghai Industrial Financial (Holdings) Company Limited, SIIC Trading Company Limited, The Tien Chu Ve Tsin (Hong Kong) Company Limited, South Pacific International Trading Limited, Billion More Investments Limited, SIIC Treasury (B.V.I.) Limited, SIIC CM Development Funds Limited, South Pacific Hotel (Hong Kong) Limited and SIIC CM Development Limited held 519,409,748 Shares, 80,000,000 Shares, 13,685,000 Shares, 6,506,000 Shares, 2,430,000 Shares, 1,479,000 Shares, 1,219,000 Shares, 729,000 Shares, 698,000 Shares, 376,000 Shares and 10,000 Shares respectively, and is accordingly deemed to be interested in the respective Shares totaling 626,541,748 Shares held by the aforementioned companies, representing approximately 57.81 percent of the total number of Shares in issue.

Assuming no changes in the aforementioned shareholdings of the respective companies, in the event that the Directors exercise in full the power to buy back the Shares, the shareholding of SIIC would be increased from approximately 57.81 percent to approximately 64.23 percent. Such increase would not give rise to an obligation to make a mandatory offer in accordance with Rule 26 of the Takeovers Code. The Directors are not aware of any consequences of any buy-back which would arise under the Takeovers Code. In addition, the Company will not buy back its Shares which will reduce the total number of Shares in issue in public hands to below 25 percent.

There is no service agreement entered into between Prof. Woo and the Company. He is entitled to receive a director's fee of HK\$250,000 per annum and fees for serving on the respective Board Committees of the Company totaling HK\$190,000 per annum.
