### **INTRODUCTION**

The purpose of this circular is to provide you with information in connection with the convening of the 2018 Annual General Meeting and explanation in connection with the matters to be dealt with at the 2018 Annual General Meeting.

The Notice is set out on pages 14 to 17 of this circular.

Shareholders are advised to read the Notice and to complete and return the accompanying form of proxy for use at the 2018 Annual General Meeting in accordance with the instructions printed thereon.

For the purpose of determining Shareholders' eligibility to attend and vote at the 2018 Annual General Meeting, the register of members of the Company will be closed on Tuesday, 15 May 2018, to Wednesday, 16 May 2018, both days inclusive, during which period no transfer of shares will be effected. As such, all transfers accompanied by the

relevant share certificates must be lodged with the Company's share registrar, Tricor Secretaries Limited of 22nd Floor, Hopewell Centre, 183 Queen's Road East, Hong Kong by 4:30 p.m. on Monday, 14 May 2018.

Pursuant to the Listing Rules, all resolutions put to vote at the 2018 Annual General Meeting shall be taken by poll except where the chairman of the meeting, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands.

### **BUSINESS OF 2018 ANNUAL GENERAL MEETING**

#### ***Resolution (1) – Receiving the audited consolidated financial statements***

The audited consolidated financial statements of the Company for the year ended 31 December 2017 together with the reports of the directors and the auditor were set out in the Annual Report, and were sent together with this circular to the Shareholders on the same date.

The audited consolidated financial statements have been audited by Deloitte Touche Tohmatsu and reviewed by the audit committee of the Company.

#### ***Resolution (2) – Declaration of final dividend***

The Board of Directors has recommended a final dividend of HK48 cents per share (2016: HK46 cents per share). Together with the interim dividend of HK46 cents per share (2016: HK36 cents per share and the special dividend of HK10 cents per share) paid during the year, total dividends for the year ended 31 December 2017 amounted to HK94 cents per share (2016: HK82 cents per share and a special dividend of HK10 cents per share).

Subject to approval by the Shareholders at the 2018 Annual General Meeting, the final dividend will be paid on or about Tuesday, 12 June 2018 to Shareholders whose names appear on the register of members of the Company on Thursday, 31 May 2018.

For the purpose of determining Shareholders' entitlement to the final dividend, the register of members of the Company will be closed on Thursday, 31 May 2018, on which no transfer of shares will be effected. As such, all transfers accompanied by the relevant share certificates must be lodged with the Company's share registrar, Tricor Secretaries Limited of 22nd Floor, Hopewell Centre, 183 Queen's Road East, Hong Kong by 4:30 p.m. on Wednesday, 30 May 2018.

#### ***Resolution (3) – Re-election of Directors and determination of Directors' remuneration***

In accordance with Article 101 of the Articles of Association of the Company, Mr. Zhou Jun, Prof. Woo Chia-Wei and Mr. Cheng Hoi Chuen, Vincent shall retire at the 2018 Annual General Meeting and, being eligible, have offered themselves for re-election.

The Board appointed Mr. Shen Xiao Chu as an Executive Director and the Chairman of the Company on 28 February 2018. Detail of such appointment was set out in the announcement of the Company dated 28 February 2018.

According to Article 92 of the Articles of Association of the Company, any Director appointed to fill a casual vacancy or as an addition to the Board shall hold office only until the next following annual general meeting of the Company. However, a retiring Director shall be eligible for re-election. Being eligible, Mr. Shen Xiao Chu will offer himself for re-election as Director.

Also, pursuant to the code provisions set out in the Corporate Governance Code of Appendix 14 to the Listing Rules, if an independent non-executive director serves more than 9 years, his further appointment should be subject to a separate resolution to be approved by shareholders. Prof. Woo Chia-Wei acted as Independent Non-Executive Director of the Company since March 1996, serving the Board for more than 9 years. Separate resolution will be proposed for his re-election at the 2018 Annual General Meeting.

The Board considers that Prof. Woo Chia-Wei remains independent as he has satisfied all the criteria for independence set out in Rule 3.13 of the Listing Rules.

Shareholders are recommended to vote in favour of the re-election of Mr. Shen Xiao Chu, Mr. Zhou Jun, Prof. Woo Chia-Wei and Mr. Cheng Hoi Chuen, Vincent as the Board believes that their qualifications and extensive experience are of great value to the Board. Their biographical details and other information which are required to be disclosed by the Listing Rules are set out in Appendix II to this circular.

The remuneration committee of the Company has made recommendation to the Board on the directors' remuneration for the year ending 31 December 2018, and the basis of determining the directors' remuneration is set out in the corporate governance report of the Annual Report.

### ***Resolution (4) – Re-appointment of auditor and determination of auditor's remuneration***

The audit committee has recommended to the Board for the re-appointment of Messrs. Deloitte Touche Tohmatsu as auditor of the Company until the conclusion of the next annual general meeting.

Shareholders' approval to delegate the authority to the Directors to determine the auditor's remuneration for the year ending 31 December 2018 is required at the 2018 Annual General Meeting.

### ***Resolution (5) – General mandates to buy back shares***

At the annual general meeting held on 22 May 2017, a general mandate was given to the Directors to buy-back Shares up to a maximum of 10 percent of the issued share capital of the Company at the date of passing of the ordinary resolution. Such mandate will lapse at the conclusion of the 2018 Annual General Meeting. An ordinary resolution set out in the Notice will be proposed at the 2018 Annual General Meeting to grant the Buy-back Mandate to the Directors.

As at the Latest Practicable Date, the total number of Shares in issue was 1,087,211,600. On the basis that no further Shares are issued or bought back prior to the date of the 2018 Annual General Meeting, the Company would be allowed under the Buy-back Mandate to buy back a maximum of 108,721,160 Shares, representing 10 percent of the total number of Shares in issue as at the Latest Practicable Date.

The Buy-back Mandate would continue in force until the conclusion of the next annual general meeting of the Company or the expiration of the period within which the next annual general meeting of the Company is required by law or the Articles of Association of the Company to be held or until the Buy-back Mandate is revoked or varied by an ordinary resolution of the Shareholders in general meeting, whichever is the earlier.

The explanatory statement required by the Listing Rules to be included in this circular is set out in Appendix I to this circular.

### ***Resolutions (6) and (7) – General mandate to issue shares***

At the annual general meeting held on 22 May 2017, a general mandate was given to the Directors to allot, issue and deal with Shares (and securities exercisable or convertible into Shares) not exceeding 20 percent of the issued share capital of the Company at the date of passing of the ordinary resolution. The unused portion of the mandate will expire at the conclusion of the 2018 Annual General Meeting. Two ordinary resolutions will be proposed at the meeting to grant the Issue Mandate to the Directors and to extend the Issue Mandate by adding to it the number of Shares bought back by the Company under the Buy-back Mandate respectively.

As at the Latest Practicable Date, the total number of Shares in issue was 1,087,211,600. On the basis that no further Shares are issued or bought back prior to the date of the 2018 Annual General Meeting, the Company would be allowed under the Issue Mandate to issue a maximum of 217,442,320 Shares, representing 20 percent of the total number of Shares in issue as at the Latest Practicable Date.

The Issue Mandate would continue in force until the conclusion of the next annual general meeting of the Company or the expiration of the period within which the next annual general meeting of the Company is required by law or the Articles of Association of the Company to be held or until the Issue Mandate is revoked or varied by an ordinary resolution of the Shareholders in general meeting, whichever is the earlier.

### **RECOMMENDATION**

The Directors consider that the above recommendations are in the interests of the Company and the Shareholders. Accordingly, the Directors recommend the Shareholders to vote in favour of the above resolutions to be proposed at the 2018 Annual General Meeting.

This explanatory statement contains all the information required under the Listing Rules for you to consider the Buy-back Mandate.

The Listing Rules permit companies whose primary listings are on the Stock Exchange to buy back their fully paid up shares on the Stock Exchange subject to certain restrictions, the most important of which are summarized below:

### **SHARE CAPITAL**

As at the Latest Practicable Date, the total number of Shares in issue was 1,087,211,600. On the basis that no further Shares are issued or bought back prior to the date of the 2018 Annual General Meeting, the Company would be allowed under the Buy-back Mandate to buy back a maximum of 108,721,160 Shares, representing 10 percent of the total number of Shares in issue at the Latest Practicable Date.

### **REASONS FOR SHARE BUY-BACKS**

The Directors have no present intention to buy back any Shares and, whilst it is not possible to anticipate in advance those circumstances in which the Directors might think it appropriate to buy back Shares, Shares would only be bought back in circumstances where the Directors consider that the buy-back would be in the interests of the Company and the Shareholders. Such buy-back may, depending on market conditions and funding arrangements at the time, lead to an enhancement of earnings per Share.

### **SOURCE OF FUNDS**

It is proposed that buy-backs of Shares under the Buy-back Mandate would be financed from internal funds and available banking facilities of the Company. In Share buy-backs, the Company may only apply funds legally available for such purpose in accordance with the applicable laws of Hong Kong and the Articles of Association of the Company.

### **WORKING CAPITAL OR GEARING POSITION**

If the Buy-back Mandate was exercised in full at any time during the proposed buy-back period, it would not have a material adverse impact on the working capital of the Company or its gearing position (as compared with the position disclosed in the Company's published audited accounts for the year ended 31 December 2017). The Directors do not propose to exercise the Buy-back Mandate to such extent as would, in the circumstances, have a material adverse impact on the working capital of the Company or its gearing position (as compared with the position disclosed in the Company's published audited accounts for the year ended 31 December 2017) which in the opinion of the Directors are from time to time appropriate for the Company.

**DIRECTORS AND THEIR ASSOCIATES**

None of the Directors nor, to the best of their knowledge and belief having made all reasonable enquiries, any of their associates (as defined under the Listing Rules), has any present intention, in the event that the Buy-back Mandate is approved by Shareholders, to sell Shares to the Company.

**CONNECTED PERSONS**

No Connected Persons have notified the Company that they have a present intention to sell any Shares (in issue or to be issued) to the Company or have undertaken not to do so, in the event that the Company is authorized to make Share buy-backs.

**UNDERTAKING OF THE DIRECTORS**

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to buy back Shares pursuant to the proposed resolution in accordance with the Listing Rules, the applicable laws of Hong Kong and the regulations set out in the Articles of Association of the Company.

**EFFECT OF TAKEOVERS CODE**

If, as a result of a buy-back of Shares, a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. Accordingly, a shareholder or group of shareholders acting in concert could, depending on the level of increase of such interest, obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 and Rule 32 of the Takeovers Code.

As at the Latest Practicable Date, SIIC through its subsidiaries, namely Shanghai Investment Holdings Limited, SIIC Capital (B.V.I.) Limited, Shanghai Industrial Financial (Holdings) Company Limited, SIIC Treasury (B.V.I.) Limited, SIIC CM Development Funds Limited and SIIC CM Development Limited held 519,409,748 Shares, 80,000,000 Shares, 33,091,000 Shares, 5,895,000 Shares, 3,005,000 Shares and 10,000 Shares respectively, and is accordingly deemed to be interested in the respective Shares totaling 641,410,748 Shares held by the aforementioned companies, representing approximately 59 percent of the total number of Shares in issue.

Assuming no changes in the aforementioned shareholdings of the respective companies, in the event that the Directors exercise in full the power to buy back the Shares, the shareholding of SIIC would be increased from approximately 59 percent to approximately 65.55 percent. Such increase would not give rise to an obligation to make a mandatory offer in accordance with Rule 26 and Rule 32 of the Takeovers Code. The Directors are not aware of any consequences of any buy-back which would arise under the Takeovers Code. In addition, the Company will not buy back its Shares which will reduce the total number of Shares in issue in public hands to below 25 percent.

**SHARE BUY-BACKS**

No buy-back had been made by the Company of its Shares in the last six months prior to the Latest Practicable Date.

The following are the particulars of the Directors proposed to be re-elected at the 2018 Annual General Meeting as required under the Listing Rules:

**Mr. SHEN Xiao Chu**

*Executive Director, Chairman and the chairman of the Executive Committee*

(Appointed on 28 February 2018 ~ Present)

Mr. Shen, aged 56, is currently the chairman of Shanghai Industrial Investment (Holdings) Company Limited. He graduated from Shanghai Second Medical University and Shanghai Jiaotong University respectively and holds a bachelor's degree in medicine, a bachelor's degree in law and an executive master of business administration, and is designated a deputy professor. Mr. Shen was a deputy officer of the Principal Office of Shanghai Second Medical University, deputy director of Shanghai Huangpu District Hygiene Bureau, hospital dean of Huangpu District Central Hospital, deputy mayor of Huangpu District, Shanghai, deputy mayor of Changning District, Shanghai, deputy officer of Shanghai Municipal Development and Reform Commission, officer of Shanghai Municipal Commission of Health and Family Planning, officer of Shanghai Municipal Development and Reform Commission and deputy secretary-general of the Shanghai Municipal Government. He has extensive experience in the leadership role in government authorities as well as in economics, people's livelihood, medical and urban construction and management. Mr. Shen is a member of the 15th Shanghai Municipal People's Congress.

As at the Latest Practicable Date, Mr. Shen was not interested or deemed to be interested in any shares or underlying shares of the Company or its associated corporations pursuant to Part XV of the SFO.

Save as disclosed above, Mr. Shen did not hold any directorship in any other public companies, the securities of which are listed on any securities market in Hong Kong or overseas, in the past three years, nor did he have any relationship with any Directors, senior management or substantial or controlling Shareholders of the Company.

Mr. Shen has a service agreement with the Company, pursuant to which, he is entitled to receive a basic salary of HK\$3,257,968 per annum (subject to review by the Remuneration Committee from time to time). In addition, he may receive a discretionary bonus payment subject to the absolute discretion of the Company having regard to the operating results of the Group, prevailing market conditions and his performance. The Director's emoluments are determined by reference to factors such as the Company's operating performance, industry benchmark, time contributed by the Director and job responsibilities.

Save as disclosed above, as at the Latest Practicable Date, there were no other matters relating to Mr. Shen's re-election that need to be brought to the attention of the Shareholders nor any information required to be disclosed pursuant to any of the requirements of Rule 13.51(2) of the Listing Rules.

**Mr. ZHOU Jun**

*Executive Director, Vice Chairman, Chief Executive Officer and a member of the Executive Committee*

(Appointed on 15 April 2009 ~ Present)

Mr. Zhou, aged 49, is an executive director and the president of Shanghai Industrial Investment (Holdings) Company Limited (“SIIC”). He is also the chairman of SIIC Environment Holdings Ltd., the shares of which are dually listed on the Main Board of the Hong Kong Stock Exchange and the Main Board of the Singapore Stock Exchange, the chairman of SIIC Management (Shanghai) Ltd., Shanghai Hu-Ning Expressway (Shanghai Section) Co., Ltd., Shanghai Luqiao Development Co., Ltd., Shanghai Shen-Yu Development Co., Ltd. and a director of certain other subsidiaries of the Group. He is also a non-executive director and the chairman of Shanghai Pharmaceuticals Holding Co., Ltd., the H shares of which are listed on the Main Board of the Hong Kong Stock Exchange and the A shares of which are listed on the A Shares Market of the Shanghai Stock Exchange. He graduated from Nanjing University and Fudan University with a bachelor’s and a master’s degree in economics (international finance), and is designated an economist. Mr. Zhou currently is the chairman of Shanghai Galaxy Investment Co., Ltd. (“Shanghai Galaxy”). He worked for Guotai Securities Co., Ltd. (now Guotai Junan Securities Co.) before joining SIIC in April 1996. The management positions he had held within the SIIC group of companies were Deputy CEO of the Company, deputy general manager of SIIC Real Estate Holdings (Shanghai) Co., Ltd., deputy general manager of Shanghai United Industrial Co., Ltd., director and general manager of Shanghai Galaxy and general manager of the strategic investment department of SIIC. Mr. Zhou is currently a member of the executive committee of the Chinese People’s Political Consultative Conference in Shanghai, the chairman of Shanghai Shengtai Investment and Management Limited under Shanghai Charity Foundation and the president of Shanghai Youth Entrepreneurs Association. He has over 20 years’ professional experience in mergers and acquisitions, securities, finance, real estate, project planning and corporate management. Mr. Zhou was an executive director of Shanghai Industrial Urban Development Group Limited, the shares of which are listed on the Main Board of the Hong Kong Stock Exchange and an independent non-executive director of Zhejiang Expressway Co., Ltd., the H shares of which are listed on the Main Board of the Hong Kong Stock Exchange, during the past three years.

As at the Latest Practicable Date, Mr. Zhou had a personal interest in 195,000 ordinary Shares representing 0.02% of the total number of Shares in issue. Save as aforesaid, he was not interested or deemed to be interested in any shares or underlying shares of the Company or its associated corporations pursuant to Part XV of the SFO.

Save as disclosed above, Mr. Zhou did not hold any directorship in any other public companies, the securities of which are listed on any securities market in Hong Kong or overseas, in the past three years, nor did he have any relationship with any Directors, senior management or substantial or controlling Shareholders of the Company.

Mr. Zhou has a service agreement with the Company, pursuant to which, he is entitled to receive a basic salary of HK\$2,363,536 per annum (subject to review by the Remuneration Committee from time to time). In addition, he may receive a discretionary bonus payment

subject to the absolute discretion of the Company having regard to the operating results of the Group, prevailing market conditions and his performance. The Director's emoluments are determined by reference to factors such as the Company's operating performance, industry benchmark, time contributed by the Director and job responsibilities.
