**FURTHER DELAY IN DESPATCH OF CIRCULAR
MAJOR TRANSACTION
IN RELATION TO
ACQUISITION OF LAND USE RIGHTS OF LAND PARCELS
IN SHANGHAI, THE PRC BY THE TENDER CONSORTIUM**

Reference is made to the announcement of Shanghai Industrial Holdings Limited (the "**Company**") dated 8 May 2021 in relation to the acquisition of land use rights of land parcels in Shanghai, the PRC (the "**Announcement**") and the announcement of the Company dated 27 May 2021 in relation to the delay in despatch of circular (the "**Delay in Despatch Announcement**"). Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Announcement and the Delay in Despatch Announcement.

As disclosed in the Delay in Despatch Announcement, a circular (the "**Circular**") containing, among other things, (i) further details of the Land Acquisition and (ii) financial information of the Group is expected to be despatched to the shareholders of the Company on or before 18 June 2021. As additional time is required for the Company to (i) negotiate the possible joint venture arrangement for the development of the Land and the related construction and business operation and (ii) prepare and finalise certain information, including the statements as to the indebtedness and the sufficiency of working capital, for inclusion in the Circular, it is currently expected that the date of despatch of the Circular will be postponed to a date falling on or before 31 July 2021.
